The Ontario Ministry of Transportation (MTO) has retained Stantec Consulting Ltd. to undertake a Planning. **Preliminary** Environmental Design, and Class EA) Study Assessment (Class Highway 401 for the replacement and rehabilitation of bridges and culverts, interchange modifications, and identifying the future Highway 401 footprint for an interim six lanes and ultimate eight lanes, from 0.4 km west of Christiani Road to 1 km Wallbridge Loyalist (approximately 20 km). The purpose of the study is to identify a Recommended Plan addresses current and transportation needs in the study area as part of the Ministry's ongoing review of safety and operational needs for the provincial highway network.

THE PROCESS

This study was originally initiated under the Environmental Assessment Provincial Transportation Facilities (2000) in

2022, prior to the establishment of the 2024 Class EA, which is approved under the Ontario Environmental Assessment Act for provincial transportation projects of a defined scope and magnitude. This project will continue to follow the 2000 Class EA process as a "Group B" project and includes undertaking environmental and engineering field investigations and seeking input from Indigenous communities, the public, stakeholders, municipalities and government agencies. Upon completion of Preliminary Design, the project team will prepare a Transportation Environmental Study Report (TESR) and issue a Notice of Completion.

Once a Technically Preferred Alternative has been identified, the Ministry of Transportation may designate lands as highway and acquire property prior to EA process completion. A designation enables the Ministry to provide route/corridor protection through the application of development control measures along the corridor and in the vicinity of the designated lands.
